What is this Product?

Ordinary Shares in Aberdeen Standard European Logistics Income PLC, an actively managed investment company registered in England and listed on the London Stock Exchange. Its investment objective is to provide a regular and attractive level of income return together with the potential for long term income and capital growth from investing in high quality European logistics real estate. Currency hedging is employed to mitigate the potential volatility of income returns from the portfolio in Sterling terms and to provide greater certainty as to the level of Sterling distributions expected to be paid. The Company may borrow to purchase assets. The Company does not have a fixed life but shareholders have the opportunity to vote on the continuation of the Company in 2024 and then every 5 years thereafter. Further, in certain other circumstances the Company may be wound up following a proposal from the directors and its approval by the shareholders, subject to compliance with relevant legal and regulatory requirements. Aberdeen Standard Fund Managers Limited may not unilaterally terminate the Company. Shares in the Company are bought and sold on a stock market. Investment in the Company is only suitable for investors who are comfortable with the risks and investment time horizon set out in this document and may not be appropriate if you plan to sell some or all of your shares within 5 years. What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the Company is not able to pay you.



The risk indicator assumes you keep the product for at least 5 years. The actual risk can vary significantly. The value of investments and the income from them can go down as well as up, and you may get back less than you invested.

We have classified this product as 5, which is a medium high risk class. This rates the potential losses from future performance at a medium high level, and poor market conditions could impact the amount you could get back.

If the product is not held for the recommended holding period, the potential risk may be significantly higher than the one shown above.

This product does not include any protection from future market performance so you could lose some or all of your investment.

What happens if the Company is unable to pay out?

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The other ongoing costs set out above represent the costs of the Company including property operating expenses, administration costs associated with the ongoing running of an investment trust and also the investment management fee. Financing costs of 0.58% are not included in the costs set out above.

How long should I hold it and can I take money out early?

This product has no required minimum holding period but is designed for medium to long-term investment. Since the value of investments and the income from them can rise and fall over differing time periods, you should have an investment horizon of at least 5 years when buying an investment of this type.

The minimum recommended holding period is therefore 5 years.

As the shares are listed on the London Stock Exchange, you may buy or sell shares on any normal business day that the London Stock Exchange is open for business.
