# What is this product?

#### Type

The Company's shares are listed on the premium segment of the Official List of the UK Listing Authority ('UKLA') and are admitted to trading on the main market of the London Stock Exchange.

### **Objectives**

Aims to achieve capital growth from investing in medium sized UK listed companies. The Company specialises in investment in FTSE 250 companies, using long and short term borrowings to increase returns to shareholders. The Company will focus on FTSE 250 stocks that deliver strong capital growth and it will have significant exposure to the UK economy. It will seek out both value stocks and growth stocks, including AIM stocks, to deliver strong performance throughout the market cycle. It emphasises growth rather than income. Returns are principally determined by the performance of the investments made by The Company, although The Company has the ability to use borrowing to gear the portfolio within the range of 5% net cash to 25% geared in normal market conditions. Gearing may magnify gains or losses experienced by The Company.

#### Intended retail investor

The Company is offered to investors who may have basic or no knowledge and experience of investing in financial markets and also experienced investors and is intended for long-term investment. Investors should understand the risks involved, including the risk of losing all capital invested and must evaluate The Company's objective and risks in terms of whether they are consistent with their own investment goals and risk tolerances. Shares in The Company are not intended as a complete investment plan.

The Company has been established with an unlimited life.

### What are the costs?
