You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

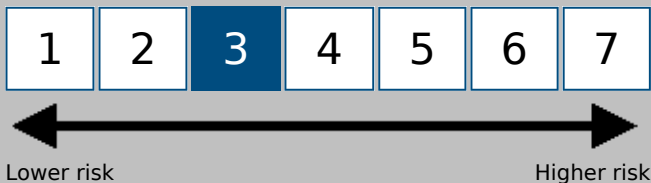
Type 2025 zero dividend preference shares in EJF Investments Ltd ("the **Company**"), a closed-ended investment company incorporated in the Bailiwick of Jersey. Save for a payment on the ZDP repayment date of 18 June 2025 (with the actual payment being made 14 days thereafter) when the 2025 zero dividend preference shares will be redeemed, the Company is not expecting to pay you although you may generate returns through selling your shares through a bank or stockbroker. Shares of the Company are bought and sold via markets. Typically, at any given time on any given day, the price you pay for a share will be higher than the price at which you could sell it. Holders of 2025 zero dividend preference shares will not be paid any dividends by the Company.

Objectives The Company's investment objective is to pay the final capital entitlement of 140 pence per 2025 zero dividend preference share on 18 June 2025. The final capital entitlement is not a guaranteed repayment amount.

Intended retail investor The 2025 zero dividend preference shares are admitted to trading on the Specialist Fund Segment of Main Market of the London Stock Exchange and as such as intended for institutional, professional and highly knowledgeable (including those who are professionally advised) investors. The 2025 zero dividend preference shares are not intended for retail investors.

Maturity date 18 June 2025.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product until 18-06-2025.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity to pay you.

If you sell your shares on the London Stock Exchange, your bank or stockbroker will receive cash on delivery of your shares and should pass that to you.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for three different holding periods. They include potential early exit penalties. The figures assume you invest GBP 10 000. The figures are estimates and may change in the future.
