What is this product?

WisdomTree Long CHF Short GBP is designed to enable investors to gain exposure to Swiss Franc ("CHF") relative to Pounds Sterling ("GBP") by tracking the MSFX Long Swiss Franc/GBP Index (TR) (the "Index"), which aims to reflect the performance of a position in forward contracts which are rolled on a daily basis. The product provides a long exposure to CHF relative to GBP. For example, if CHF were to rise in value relative to GBP, the Index (tracked by the ETC) would rise in value. Conversely if CHF were to decrease in value relative to GBP, the Index return also includes a component based on the interest rate differentials, reflecting the difference between the CHF and the GBP exchange rates. The Index is a total return Index, which means that it also provides a collateral yield. The product is an exchange traded product ("ETP"). Securities in this ETP are structured as debt securities and not as shares (equity). They are traded on exchange just like shares in a company. The ETP is backed by swaps with Morgan Stanley & Co. International plc. The payment obligations of the Issuer are protected by collateral held in a segregated account at an independent custodian, The Bank of New York Mellon.

Intended retail investor:

The product is intended for basic retail investors who: (i) can bear loss of capital, are not seeking to preserve capital and who are not looking for capital guarantee; (ii) have specific knowledge or experience of investing in similar products and in financial markets; and (iii) seek a product offering an exposure to the performance of the underlying asset(s) and have an investment horizon in line with the recommended holding period stated below.



The risk indicator assumes you keep the product for 6 months. The actual risk can vary significantly if you cash in at an early or later stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified the risk classes of the underlying investment strategies as 3 out of 7

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the performance.
