Objective and investment policy

Objective: The fund aims to provide a combination of capital growth and income, net of the Ongoing Charge Figure, that is higher than the average return of the IA Mixed Investment 40-85% Shares Sector over any five-year period.

Core investment: The fund typically invests in a mix of assets, including company shares, bonds, convertibles and currencies. The fund may invest in these assets directly, via derivatives or through other funds. At least 25% of the fund is held in sterling and at least 50% of the fund is held in US dollar, sterling, yen and euro combined.

Other investments: The fund may invest in other assets (such as property) via derivatives or through other funds.

Derivatives usage: For investment purposes and to reduce risk and costs.

Strategy in brief: The fund has a very flexible investment approach, with the freedom to invest in different types of assets in response to changes in economic conditions and the valuation of assets. The fund typically invests 40-85% of its assets in company shares and convertibles, 15-50% in bonds or cash, and up to 10% in other assets. These allocations reflect the net exposure of the portfolio. The approach combines in-depth research to work out the "fair" value of assets over the medium to long term, with analysis of market reactions to events to identify investment opportunities. In particular, the fund manager seeks to respond when asset prices move away from a reasonable sense of "fair" long term value due to the market's reaction to events.

Benchmark: IA Mixed Investment 40-85% Shares Sector

The benchmark is a target which the fund seeks to outperform. The sector has been chosen as the fund is a constituent of the sector. The benchmark is used solely to measure the fund's performance and does not constrain the fund's portfolio construction.

The fund is actively managed. The fund manager has complete freedom in choosing which investments to buy, hold and sell in the fund.

For unhedged and hedged share classes, the benchmark is shown in the share class currency.

Other information

You can buy and sell shares in the fund on any business day. Instructions received before 12 noon will be dealt at that day's price.

Any income from the fund will be rolled up into the value of your investment.

In addition to the charges set out in the charges section, the fund will incur portfolio transaction costs which are paid from the assets of the fund. These can be higher when investing outside Europe.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Risk and reward profile

The main risks that could affect performance are set out below:

■ The value and income from the fund's assets will go down as well as up. This will cause the value of your investment to fall as well as rise. There is no guarantee that the fund will achieve its objective and you may get back less than you originally invested.

The charges shown in the table are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

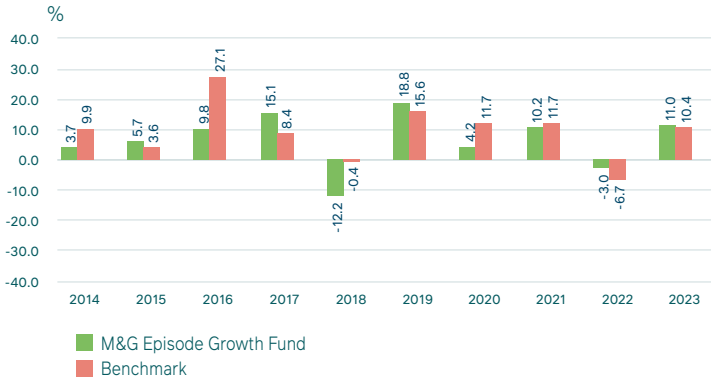
