### Objective and investment policy

#### Objective:

The fund aims to provide:

- A growing level of income over any three-year period; and
- Capital growth of 2-4% per annum, net of the Ongoing Charge Figure, over any three-year period.

There is no guarantee that the fund will achieve its objective over this, or any other, period. The income distributions and the value of investments may rise and fall, and investors may not recoup the amount they originally invested.

**Core investment:** The fund typically invests directly in a mix of assets including company shares, bonds, currencies and property (only through other funds). The fund may also invest in these assets via derivatives or through other funds. A minimum of 70% of the fund is in sterling or hedged back to sterling.

**Other investments:** The fund may invest in cash or assets that can be turned into cash quickly.

**Derivatives usage:** For investment purposes and to reduce risk and cost.

**Strategy in brief:** The fund employs a flexible investment approach with the freedom to invest in different types of assets from anywhere in the world in response to changes in economic conditions and the valuation of assets. The approach combines in-depth research to work out the value of assets over the medium to long term, with analysis of market reactions to events to identify investment opportunities. The fund typically invests 20-50% of its assets in company shares, 40-80% in bonds and up to 20% in other assets, which can include convertibles.

**Benchmark:** The fund is actively managed and it has no benchmark. Investors can assess the performance of the fund by its objective to provide a growing level of income and capital growth of 2-4% per annum, both measured over any three-year period. The fund's annual report for each financial year will include details of the fund's performance in relation to its objective.

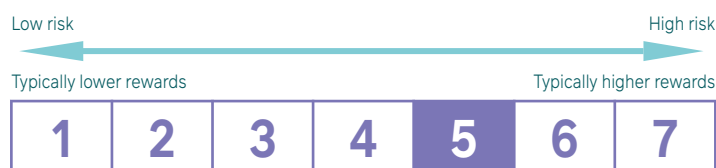
You can buy and sell shares in the fund on any business day. Instructions received before 12 noon will be dealt at that day's price.

Any income from the fund may be paid out to you monthly.

In addition to the charges set out in the charges section, the fund will incur portfolio transaction costs which are paid from the assets of the fund. These can be higher when investing outside Europe.

**Recommendation:** This fund may not be appropriate for investors who plan to withdraw their money within 3 years.

### Risk and reward profile

#### The main risks that could affect performance are set out below:

■ The value and income from the fund's assets will go down as well as up. This will cause the value of your investment to fall as well as rise. There is no guarantee that the fund will achieve its objective and you may get back less than you originally invested.

■ Investments in bonds are affected by interest rates, inflation and credit ratings. It is possible that bond issuers will not pay interest or return the capital. All of these events can reduce the value of bonds held by the fund.

■ The fund is exposed to different currencies. Derivatives are used to minimise, but may not always eliminate, the impact of movements in currency exchange rates.

■ Investing in emerging markets involves a greater risk of loss due to greater political, tax, economic, foreign exchange, liquidity and regulatory risks, among other factors. There may be difficulties in buying, selling, safekeeping or valuing investments in such countries.

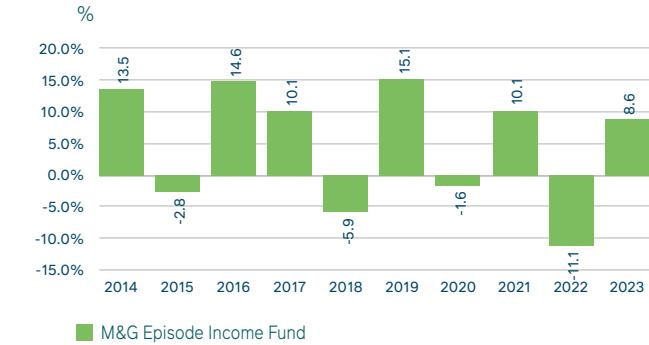
The entry and exit charges shown are the maximum figures and, in some cases, you may pay less. The ongoing charge is based on expenses for the period/year ending 31 October 2023. This figure may change from year to year. It excludes portfolio transaction costs. This figure includes extraordinary expenses and underlying charges for closed-ended-funds, such as investment trusts and Real Estate investment trusts.

For Income shares, the ongoing charge is taken from investments held in the fund's portfolio and not from the income these investments produce. The deduction of this charge will reduce the potential growth of your investment.
