This fund is managed by Schroder Investment Management (Europe) S.A., which is a member of the Schroders Group.

Objectives and investment policy

Objectives The fund aims to provide capital growth in excess of the MSCI BIC (Net TR) 10/40 Index, after fees have been deducted over a three to five year period by investing in equities of Brazilian, Indian and Chinese companies. Investment policy The fund is actively managed and invests at least two-thirds of its assets in a range of equities of Brazilian, Indian and Chinese companies. The fund may invest directly in China B-Shares and China H-Shares and may invest less than 20% of its assets (on a net basis) directly or indirectly (for example via participatory notes) in China A-Shares through Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect and shares listed on the Science Technology and Innovation (STAR) Board and the ChiNext. The fund may also invest up to one-third of its assets directly or indirectly in other securities (including other asset classes), countries, regions, industries or currencies, investment funds, warrants and money market investments, and hold cash (subject to the restrictions provided in the prospectus). The fund may use derivatives with the aim of achieving investment gains, reducing risk or managing the fund more efficiently. Benchmark	The fund's performance should be assessed against its target benchmark being to exceed the MSCI BIC (Net TR) 10/40 Index. The fund's investment universe is expected to overlap materially, directly or indirectly, with the components of the target benchmark. The investment manager invests on a discretionary basis and there are no restrictions on the extent to which the fund's portfolio and performance may deviate from the target benchmark. The benchmark(s) does/do not take into account the environmental and social characteristics or sustainable objective (as relevant) of the fund. Other Information The fund maintains a higher overall sustainability score than the MSCI BIC (Net TR) 10/40 index, based on the investment manager's rating criteria. 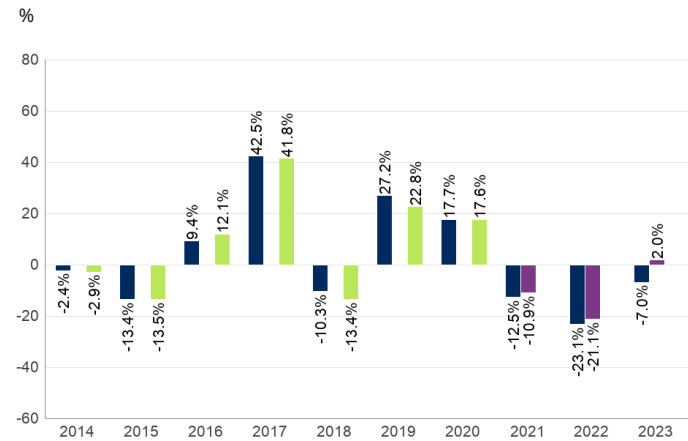
The charges you pay are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.
