OBJECTIVES AND INVESTMENT POLICY

Investment Objective

To generate growth over the long term (5 years or more) by investing in Japanese equities (company shares).

Performance Target: To achieve the return of the MSCI Japan Index, plus 3% per annum over rolling three year periods (before charges). There is no certainty or promise that the Performance Target will be achieved. The MSCI Japan Index (the "Index") is a representative index of the Japanese stock market.

Investment Policy

Portfolio Securities

- The fund will invest at least 70% in Japanese equities. - The fund may also invest in other funds (including those managed by abrdn), cash and assets that can be turned into cash quickly.

Management Process

- The management team use their discretion (active management) to maintain a diverse asset mix at sector and company level. - Their primary focus is on company selection using research techniques Their primary focus is on company selection using research technique to select individual holdings. The research process is focused on finding attractive high quality companies that can be held for the long term through the assessment of their business, the industry they operate in, their financial strength and the capability of their management team.
 Due to the active nature of the management process, the fund's performance profile may deviate significantly from that of the Index.

Derivatives and Techniques

Derivatives are linked to the value of other assets. In other words, they derive their price from one or more underlying asset.
Derivative usage in the fund is expected to be very limited. Where derivatives are used, this would mainly be in response to significant inflows into the fund so that in these instances, cash can be invested while maintaining the fund's existing allocations to company shares.


