Xtrackers

Xtrackers Euro Stoxx 50 ex Financials UCITS ETF Share Class: 1D (ISIN: LU0835262626), (WKN: DBX0NE), (Currency: EUR) a sub fund of Xtrackers. The Fund is managed by DWS Investment S.A., part of the DWS Group.

Objectives & Investment Policy

The aim is for your investment to reflect the performance of the EURO STOXX 50° ex Financials Index (Index) which is designed to reflect the performance of the shares of 50 of the largest companies in certain industry sectors in the Eurozone excluding companies from the financial section. The companies are selected on the basis that they have the largest combined value of readily available shares compared to other companies. A company's weighting in the Index depends on its relative size but cannot exceed 10% of the Index at each quarterly review date.

The Index is a price return Index. This means that the level of the Index does not include any dividends or distributions made by the companies. The Index is reviewed and rebalanced on at least a quarterly basis.

To achieve the aim, the Fund will attempt to replicate the Index by buying all (or, on an exceptional basis, a substantial number

The Fund may receive income in respect of the securities held by the fund.

The Fund may employ techniques and instruments in order to manage risk, reduce costs and improve results. These techniques and instruments may include the use of derivatives. The Fund may also engage in secured lending of its investments to certain eligible third parties to generate additional income to offset the costs of the Fund.

Dividends may be paid on your shares up to four times per annum.

You may redeem your shares on demand on a daily basis.

DWS entities and related companies may act in several roles in relation to the Fund such as distributor and management company which may involve conflicts of interest.

The Fund is not guaranteed and your investment is at risk. The value of your investment may go down as well as up.

The value of an investment in shares will depend on a number of factors including, but not limited to, market and economic conditions, sector, geographical region and political events.

Your investment is dependent on the performance of the Index less costs but your investment is not expected to match that performance precisely.

The Index is rules-based and is not capable of being adjusted to take into account changing market circumstances. As a result you may be negatively affected by, or may not benefit from, the lack of such adjustments in changing market circumstances.

The Fund may use derivatives to try to manage its investments more efficiently. This may not always be successful and may result in greater fluctuations in the value of the Fund. 
Charges

To the extent the Fund undertakes securities lending to generate revenue, the Fund will ultimately be allocated 70% of the associated revenue, the securities lending agent, which will be a DWS entity or other Deutsche Bank entity, will be allocated 15% and the remaining 15% will be allocated to the DWS entity which monitors such activities, as set out in the prospectus. To facilitate this the Fund may receive associated revenues and allocate revenue to the securities lending agent and DWS entity which monitors such activities, in the proportions set out in the prospectus. As securities lending revenue sharing does not increase the costs of running the Fund, this has been excluded from the ongoing charges.
