abrdn MyFolio Index IV Fund, a Sterling denominated sub fund of the abrdn OEIC III, Platform P Fixed Acc Shares (ISIN: GB00BHZCQZ68). This fund is managed by abrdn Fund Managers Limited.

OBJECTIVES AND INVESTMENT POLICY

Investment Objective

To generate growth over the long term (5 years or more) while being managed to a defined level of risk. The fund is part of the MyFolio Index range, which offers five funds with different expected combinations of investment risk and return. This fund is risk level IV, which aims to be the

Risk Target: The defined level of risk referred to above that the management team is targeting is within the range of 60–90% of world stock markets (represented by the MSCI World Index), over 10 years. There is no certainty or promise that this target will be achieved. The Risk Target has been chosen as it represents a risk range which is appropriate for the fund.

Performance Comparator: For comparison purposes, investors can Performance Comparator: For comparison purposes, investors can compare the fund's long term performance to a basket of assets (before charges) with a risk profile at the lower range of the Risk Target stated above (i.e. 60% of world stock markets), which is considered appropriate given the investment policy and Risk Target of the fund. This basket is composed 20% FTSE All-Share Index, 40% MSCI World ex UK Index and 40% SONIA Index.

Investment Policy

Portfolio Securities

- The fund will invest at least 80% in passively managed (which aim to replicate performance of a market index) funds and up to 20% in actively managed funds (which invest using manager discretion) including those managed by abrdn, to obtain broad exposure to a range

of diversified investments. - Typically, at least 60% of the fund will be invested in assets traditionally viewed as being higher risk such as such as equities (company shares), and emerging market bonds (which are like loans to companies or governments that pay a rate of interest, invested in regions including Eastern Europe, Asia, Africa, Latin America and the Middle East). - The rest of the fund is invested in a selection of other assets such as cash, assets that can be turned into cash quickly, government bonds

Derivatives and Techniques

The fund is not expected to invest in derivatives directly however it may invest in other funds which use derivatives. - Derivatives are linked to the value of other assets. In other words, they

derive their price from one or more underlying asset.

Investors in the fund may buy and sell shares on any dealing day (as defined in the Prospectus).

If you invest in income shares, income from investments in the fund will be paid out to you. If you invest in accumulation shares, income will be added to the value of your shares. 
