Objective and investment policy

Objective

The fund aims to achieve a positive return independent of prevailing economic or market conditions over a medium to long term rolling period of at least five years whilst maintaining a moderate level of volatility. Capital is at risk and there is no guarantee that a positive return will be achieved over that, or any, time period.

Investment Policy

The fund is almost wholly invested in derivatives to obtain global equity and government and corporate debt exposure. It maintains high levels of UK Government debt securities and cash which serve as margin or collateral on the derivative positions. As the fund grows, it may invest in a combination of derivatives and, amongst other things shares, government and corporate debt securities, other funds, exchange traded funds and exchange traded notes.

Essential features of the fund:

- The fund has the discretion to invest in the investments as described above with no need to adhere to a particular benchmark.
- The fund has no specific targets in relation to market, asset class or geographic sectors.
- You can buy and sell shares in the fund on each business day.
- Income from the fund will be added to the value of your investment.
- Derivatives are used for investment purposes and to manage the risk profile of the fund.
- Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

- This indicator shows how much a fund may have risen and fallen in the past, and therefore how much a fund's returns may have varied. It is a measure of a fund's volatility. 
- Currency Risk: As the fund invests in overseas securities, movements in exchange rates may, when not hedged, cause the value of your investment to increase or decrease.
