#### **Objectives and Investment Policy**

#### Objective

We seek to grow the Fund over a rolling 5 year period after deducting fees and costs and to provide 15% more income than the MSCI All Countries World Index (Net).

#### Investment Policy

We invest at least 80% of the Fund in the shares of companies from around the world. We can also invest in bonds, other funds (including those managed by Sarasin) and cash.

The fund is actively managed. We carefully select the Fund's investments and have free choice to select companies from any country/region, sector or industry. We identify the long-term investment themes that drive growth and lead to disruption in global economies and industries, and will shape the world in which we live and invest. We select companies based on our own analysis of which are most likely to benefit from our themes, and are well placed to grow their revenues and cash flows and whether they provide attractive income levels as a result of them.

We may only use derivatives to maintain the Fund's value, manage investment risk and to gain cost-effective access to investments. Derivatives are financial contracts whose value is linked to the price of another asset (e.g. indices, rates, share prices, currencies). The Share Class's performance can be assessed by reference to the MSCI All Countries World Index (Net) (Local Currency) GBP over rolling 5 year periods as this represents the performance of shares of companies from around the world in Pounds Sterling terms.

The Fund's income can be assessed by reference to the income produced by the MSCI All Countries World Index (Net) on an annual basis as this represents the performance of shares of companies from around the world.

#### **Distribution Policy**

Any income due from your investment is reflected in the value of your shares rather than being paid out.

#### **Dealing Frequency**

You can buy and sell shares in the Fund before 12 noon GMT on any business day in London.

#### Recommendation

This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.


