## Objectives and investment policy

The fund is passively managed. INVESTMENT OBJECTIVE: The aim is for your investment to reflect the performance of the SONIA TOTAL RETURN Index® (index). DESCRIPTION OF INDEX: The index reflects the performance of a notional deposit earning interest at the rate of the Sterling Overnight Index Average (SONIA) with the interest being reinvested in the deposit daily. SONIA is the weighted average interest rate at which banks in Great Britain lend to each other on an overnight basis as calculated by the Bank of England. INDEX REBALANCING, CALCULATION AND ADMINISTRATION: The index is calculated using a specific formula and published by Deutsche Bank on a daily basis on all calendar days. INVESTMENT POLICY: To achieve the aim, the fund will invest in transferable securities and enter into financial contracts

(derivatives) with one or more swap counterparties relating to the transferable securities and the index, in order to obtain the return on the index. 
