abrdn Sterling Bond Fund, a Sterling denominated sub fund of the abrdn OEIC I, A Acc Shares (ISIN: GB00BWK26Y53). This fund is managed by abrdn Fund Managers Limited.

OBJECTIVES AND INVESTMENT POLICY

Investment Objective

To generate income and some growth over the long term (5 years or

more) by investing in Sterling-denominated bonds.

Performance Target: To achieve the return of the Markit iBoxx Sterling Overall Index plus 1% per annum (before charges). There is no certainty or promise that the Performance Target will be achieved. The Markit iBoxx Sterling Overall Index (the "Index") is a representative

index of the market for sterling denominated investment grade bonds.

Investment Policy

Portfolio Securitiés

- The fund will invest at least 80% in sterling denominated investment grade bonds (which are like loans to governments, government-related bodies and companies that pay interest and are typically regarded as having a low default risk) issued anywhere in the world.

- The fund may also invest in other bonds issued anywhere in the world,

including high yield bonds (which are like loans to companies or governments that pay a high rate of interest but have a lower credit rating than investment grade bonds). The fund has some flexibility to seek returns from currencies.

- The fund may also invest in other funds (including those managed by abrdn), cash and assets that can be turned into cash quickly.

Management Process

- The management team use their discretion (active management) to identify investments based on analysis of global economics along with analysis of an investment's prospects and creditworthiness (debt

repayment ability) compared to that of the market.

- Due to the fund's risk constraints the fund's performance is not expected to deviate significantly from that of the Index over the long

Please Note: The fund's ability to buy and sell bonds and the associated costs can be affected during periods of market stress which could include periods where interest rates move sharply.

Derivatives and Techniques

- The fund will make routine use of derivatives to reduce risk, to reduce cost and/ or generate extra income or growth consistent with the risk profile of the fund.

Derivatives are linked to the value of other assets. In other words, they derive their price from one or more underlying asset. They can generate returns when the value of these underlying assets rise (long positions) or

fall (short positions).

- Derivatives include instruments used to manage expected changes in interest rates, inflation, currencies or creditworthiness of corporations or

Investors in the fund may buy and sell shares on any dealing day (as defined in the Prospectus).

If you invest in income shares, income from investments in the fund will be paid out to you. If you invest in accumulation shares, income will be added to the value of your shares.


