Barings Investment Funds plc is an Open Ended Investment Company. Baring International Fund Managers (Ireland) Limited is the Manager of the Company.

OBJECTIVE AND INVESTMENT POLICY

Objective: To provide long term capital growth.

Investment Policy: To invest in the shares of companies from frontier markets or companies where a substantial part of their income is derived from, or whose assets are located in, frontier countries.

- Frontier Markets (e.g. Nigeria, Saudi Arabia and Vietnam) are countries which are open To investment and are still developing but are less established than emerging markets.
- The fund may invest in other types of financial instruments such as other funds and American and Global depositary receipts (which represent shares of companies and are traded on stock markets around the world).
- The fund may also invest in the shares of companies from non-frontier markets, bonds issued by governments, companies and international bodies worldwide and may hold cash on deposit.
- The fund may invest in derivatives which are linked to the rise and fall of other assets in order to generate additional capital or income for the fund, or for hedging purposes.

Distribution Policy: Any income generated will be automatically reinvested in more units/shares of the same class unless payment is specifically requested.

Dealing Frequency: Normally 12 noon (Irish time) Monday to Friday unless it is an Irish or UK public holiday. However exceptions to this are set out in the Fund Dealing Calendar which is available at www.baring.com.

Minimum recommended holding term: This Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

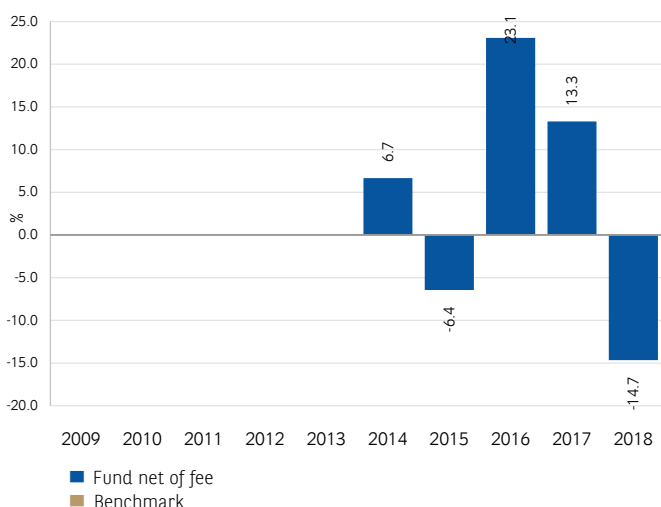
The entry and exit charges shown are maximum figures. In some cases you might pay less - you can find this out from your financial adviser.
