Objectives and Investment Policy

Classification by the French Market Regulator (AMF): Eurozone equities.

By subscribing to AMUNDI ETF LEVERAGED EURO STOXX 50 DAILY UCITS ETF, you are investing in a strategy UCITS that is managed passively, the objective of which is to replicate, as closely as possible, the performance of the EURO STOXX 50 Daily Leverage ("the Strategy Index"), whether the Strategy Index rises or falls. The target for maximum tracking error between changes in the Fund's net asset value and that of the Strategy Index is 2%.

The euro-denominated Strategy Index, net dividends reinvested (dividends net of tax paid by the equities in the Index are included in the calculation of the Index), is calculated and published by the index provider STOXX.

The EURO STOXX 50 Daily Leverage Strategy Index tracks the performance of a strategy which consists in doubling exposure to the EURO STOXX 50. It accordingly offers double exposure to the upward and downward trends experienced by the EURO STOXX 50 index. Thus, if the EURO STOXX 50 index rises by 1%, the Fund's NAV will rise by 2%, less borrowing costs, and conversely if the index falls by 1% the Fund's NAV will fall by 2%, less borrowing costs. The equities that make up the EURO STOXX 50 Index are drawn from the 50 leading securities of twelve Eurozone countries. The leverage is daily. The performance of the leveraged index over a period longer than 1 day can therefore differ substantially by 2 times the performance of the index without leverage over the same period. This effect may be amplified if the market is volatile.

The Strategy Index is available via Reuters (.SX5TL) and Bloomberg (SX5TL).

To track the Index, the UCITS swaps the performance of the assets held by the Fund for that of the Index through a derivative contract or total return swap (a "TRS" derivative instrument) (swap-based replication of the Index).

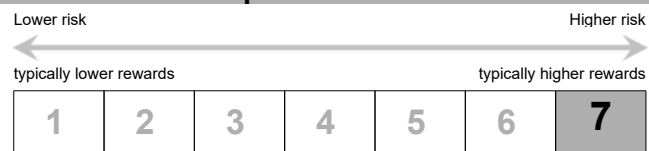
Through the Portfolio, you will be permanently invested at a level of at least 75% in stocks eligible for the Plan d'Epargne en Actions (PEA, tax wrapper reserved to residents in France).

The Fund's net profit and net realised capital gains are reinvested or redistributed each year at the discretion of the Management Company.

You may resell your units during the trading hours of the various stock exchanges, provided that the Market Makers can maintain market liquidity.

Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within 5 years.

Risk and reward profile



This Fund's risk category reflects the market risk of the European equities in which it is invested and the leverage strategy of the index.

The initial capital invested is not guaranteed.

Particular risks for the Fund not included in these indicator are:

- Counterparty risk: this is the risk of default by a market operator, including a total return swap counterparty, that prevents it from honouring its obligations to the Fund.
- The leverage strategy for the Strategy Index is used to obtain a daily multiple (x2) of the movements of the equities in the EURO STOXX 50 Index.

The occurrence of one of these risks may decrease the net asset value of your portfolio.

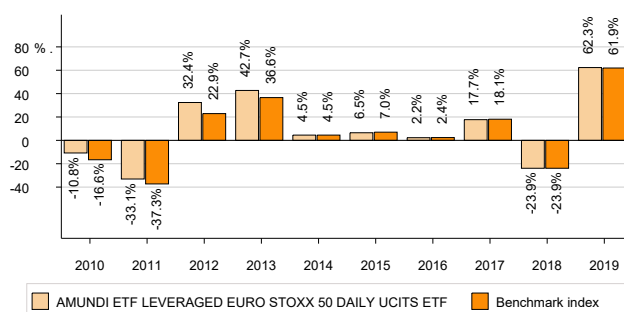
