Objective and Investment Policy

Investment Objective

The aim of the Fund is to generate a high level of income by investing into the AXA World Funds-European High Yield Bonds (the "Master Fund").

Investment Policy

The Fund is a feeder fund which means that at least 85% of its investment will be in the Master Fund. The Master Fund invests mainly (meaning, in practice, more than 70% of its investments) in a diversified portfolio of high yield bonds issued by companies anywhere in the world and denominated currencies of European countries.

The manager of the Master Fund focuses on credit analysis to create a portfolio of bonds that seeks diversification across companies showing improving resilience against default. The Master Fund is managed with reference to the composition and risk profile of the BofA Merrill Lynch BB-B European Currency High Yield Constrained Index (sterling hedged). The BofA Merrill Lynch BB-B European Currency High Yield Constrained Index (sterling hedged) is designed to measure the performance of Euro and British pound sterling-denominated below investment grade corporate debt publicly issued in the eurobond, sterling domestic or euro domestic markets (and has been hedged to sterling). This index best represents the types of companies in which the Master Fund predominantly invests. However the manager of the Master Fund invests on a discretionary basis with a significant degree of freedom to take positions which are different from the index. Where bonds are denominated in a currency other than Sterling, the Master Fund aims to reduce the risk of movements in exchange rates between such currency and Sterling through the use of derivatives (financial instruments which derive their value from the value of other assets). It is anticipated that the investment returns of the Fund will be very similar to those of the Master Fund.

The Master Fund is actively managed in reference to the BofA Merrill Lynch

BB-B European Currency High Yield Constrained Index (Sterling hedged), which may be used by investors to compare the Fund's performance.

Income

Income from investments in the Fund may be paid out to you directly if you hold income units.

Fund Currency

The reference currency of the Fund is Sterling.

Investment Horizon

This Fund may not be suitable for investors who plan to withdraw their contribution within five years.

Processing of subscription and redemption orders

Your orders to buy, sell or transfer shares in the Fund, must be received by the Administrator by the dealing cut off of 12 noon on any working day. The Funds Valuation Point will be at 5pm GMT. If the Administrator does not receive orders by 12 noon, the investors orders will be placed on the basis of the published price on the next working day.

The Net Asset Value of this Fund is calculated on a daily basis.

Minimum initial investment: £1,000

Minimum subsequent investment: £100

Why is this Fund in this category?

The capital of the Fund is not guaranteed. The Fund is invested in financial markets and uses techniques and instruments which are subject to some levels of variation, which may result in gains or losses.

Additional Risks

Counterparty Risk: failure by any counterparty to a transaction (e.g. derivatives) with the Fund to meet its obligations may adversely affect the value of the Fund. The Fund may receive assets from the counterparty to protect against any such adverse effect but there is a risk that the value of such assets at the time of the failure would be insufficient to cover the loss to the Fund.

Geopolitical Risk: investments issued or traded on markets in different countries may involve the application of different standards and rules (including local tax policies and restrictions on investments and movement of currency), which may be subject to change. The Fund's value may therefore be impacted by those standards/rules (and any changes to them) as well as the political and economic circumstances of the country/region in which the Fund is invested.

Hedging Risk: Currency Hedging within the Fund seeks to reduce the impact of exchange rate movements of the investments' currencies relative to the

fund's base currency. Over a period of time the hedging strategy itself may create a positive or negative impact to the value of the Fund, mainly due to differences in short-term interest rates between the currencies.

Liquidity Risk: some investments may trade infrequently and in small volumes. As a result the Fund manager may not be able to sell at a preferred time or volume or at a price close to the last quoted valuation. The Fund manager may be forced to sell a number of such investments as a result of a large redemption of shares in the Fund. Depending on market conditions, this could lead to a significant drop in the Fund's value and in extreme circumstances lead the Fund to be unable to meet its redemptions.

Credit Risk: the risk that an issuer of bonds will default on its obligations to pay income or repay capital, resulting in a decrease in Fund value. The value of a bond (and, subsequently, the Fund) is also affected by changes in market perceptions of the risk of future default. The risk of default for high yield bonds may be greater than bonds of investment grade issuers.

Interest Rate Risk: fluctuations in interest rates will change the value of bonds, impacting the value of the Fund. Generally, when interest rates rise, the value of the bonds fall and vice versa. The valuation of bonds will also change according to market perceptions of future movements in interest rates.

Derivatives: derivatives can be more volatile than the underlying asset and may result in greater fluctuations to the Fund's value. In the case of derivatives not traded on an exchange they may be subject to additional counterparty and liquidity risk.

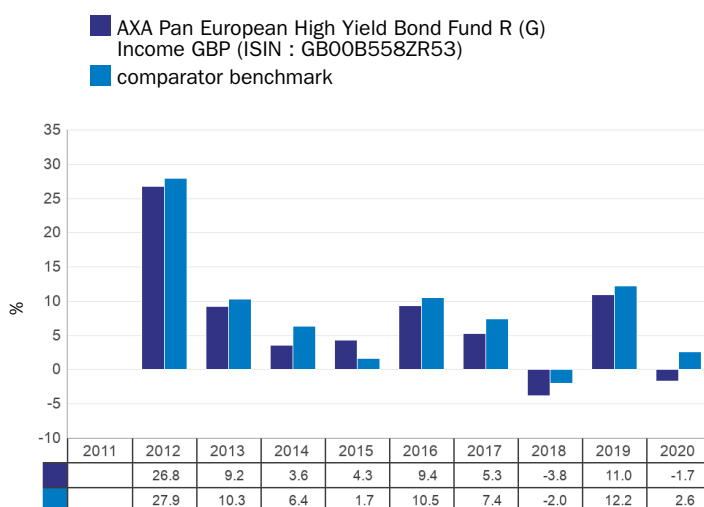
The entry and exit charges shown are maximum figures. In some cases, you might pay less - you can find this out from your Financial Adviser.
