Objectives

WisdomTree Nickel 1x Daily Short is a fully collateralised Exchange Traded Commodity (ETC) designed to provide investors with a short exposure to Nickel . The ETC provides a total return comprised of -1 times the daily performance of the Bloomberg Nickel Sub Excess Return Index (BCOMNI), plus the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Nickel Sub Excess Return Index rises by 1% over a day, then the ETC will fall by 1%, excluding fees. However if the Bloomberg Nickel Sub Excess Return Index falls by 1% over a day, then the ETC will rise by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

What are the risks and what could I get in return?



The risk indicator assumes you keep the product for 1 day. The actual risk can be significantly higher if you cash in at an early or later stage and you may get back less.
