Objective and investment policy

Objective:

The fund aims to:

 \cdot limit the average volatility to 12% per annum over any five-year period, while providing a combination of capital growth and income over that period; and

• invest in assets which meet the fund's preferred ESG standards and/or those that provide a positive societal impact through addressing the world's major social and environmental challenges.

Core investment: The fund typically invests directly in a range of assets, including company shares, bonds, cash and near cash from anywhere in the world. 20-60% of the fund is typically invested in company shares. Companies that are deemed to be in breach of the UN Global Compact principles and/or involved in industries such as tobacco or controversial weapons are excluded from the investment universe. Also excluded are companies involved in the extraction of oil and gas, and power production from coal, oil and gas or nuclear fuel. Assets selected for investment are required to meet the fund's ESG or impact criteria. 20-50% of the fund is typically invested in companies that have a positive societal impact. At least 70% of the fund is exposed to sterling.

Other investments: The fund may invest to a limited extent indirectly in other asset classes such as property and gold.

Derivatives usage: For investment purposes and to reduce risk and cost.

Strategy in brief: The fund's approach to sustainable investment is to invest in securities of companies or governments that uphold high standards of ESG behaviour. The fund seeks to manage volatility and risk through flexible asset allocation across asset classes, sectors, currencies and countries. The approach also combines research to work out the anticipated value of assets over the medium to long term, with analysis of market reactions to events, to identify investment opportunities. The fund's volatility objective may limit potential gains and losses.

Benchmark: IA Mixed Investment 20-60% Shares Sector

The benchmark is a comparator against which the fund's financial performance can be measured. The sector has been chosen as the benchmark as it reflects the financial aspects of the fund's investment policy. The benchmark does not constrain the fund's portfolio construction. The fund is actively managed. The fund manager has complete freedom in choosing which investments to buy, hold and sell in the fund within the constraints set by the fund's objective and investment policy.
