Objectives and Investment Policy

Long-term capital growth by investing in global Equity Markets with a focus on basic resources, raw materials, product processing, distribution and, if necessary, in other businesses with a focus or exposure relating to the aforementioned areas.

We manage this Sub-Fund in reference to a Benchmark. Sub-Fund's Benchmark plays a role for the Sub-Fund's performance objectives and measures. We follow an active management approach with the aim to outperform the Benchmark. Although our deviation from the investment universe, weightings and risk characteristics of the Benchmark is likely to be material in our own discretion, the majority of the Sub-Fund's investments (excluding derivatives) may consist of components of the Benchmark.

Min. 90% of Sub-Fund assets are invested by us in Equities as described in the investment objective. Max. 10% of Sub-Fund assets may be invested by us in Equities other than described in the investment objective. Max. 35% of Sub-Fund assets may be invested by us in Emerging Markets. Max. 10% of Sub-Fund

assets may be invested by us in convertible bonds and/or contingent convertible bonds. Max. 10% of Sub Fund assets may be held by us directly in deposits and/or may be invested by us in Money Market Instruments and/or (up to 10% of Sub-Fund assets) in money market funds for liquidity management. All bonds and money market instruments must have at the time of acquisition a rating of at least B- or a comparable rating from a recognised rating agency. Sub-Fund classifies as "equity-fund" according to German Investment Tax Act (GITA).
