## Objectives and Investment Policy

The Sub-Fund's objective is to seek capital appreciation by investing in a range of diversified transferable securities and/or other liquid financial assets. The Sub-Fund is actively managed by Ashmore Investment Management Limited (the "Investment Manager") and references a blended benchmark comprised of 50% EMBI GD and 50% MSCI EM Net (the "Benchmark") as part of its investment process for the purpose of comparing its performance against that of the Benchmark. The Investment Manager has full discretion over the composition of the portfolio of the Sub-Fund.

The Sub-Fund will be mainly invested in Emerging Markets Transferable Securities which are equity or debt in nature. The Sub-Fund will seek to achieve its objective through equity and bonds issued by Emerging Market corporate and quasi-sovereign entities as well as in bonds issued by sovereigns. The Sub-Fund will also invest in investment companies permitting investments in a portfolio of equities listed in an Emerging Market country. The Sub-Fund will also invest in debt, debt in nature and other instruments issued by sovereign, quasi-sovereign and corporate entities. The securities will be denominated in Emerging Market local currencies as well as US dollars and other major currencies. Corporate entities must be either domiciled in or derive at least 50% of its revenue in or from one or more Emerging Market(s).

The Sub-Fund may also be invested in financial instruments whose value derives from the value and characteristics of one or more underlying assets (derivatives) and engage in certain techniques for hedging purposes and efficient management of assets. Investments in equity-related, Money Market and derivatives instruments shall not exceed 50% of the total investments made by the Sub-Fund The Sub-Fund may not grant loans or guarantees in favour of a third party

The Sub-Fund primarily uses an active, macro top-down approach to investment management. The Sub-Fund may, on an ancillary basis, hold cash and invest in Money Market Instruments including in money market



in exchange rates will affect the value of the Sub-Fund. **Derivatives:** The Sub-Fund may also invest in derivatives whose value derives from the value and characteristics of one or more underlying asset. These derivatives may be used for hedging (against currency risk, for example) or as investments. Their use may increase the risk of losses as well as enhance potential gains compared to funds that do not

use derivatives.

Emerging Markets carry risks as well as rewards. The Sub-Fund invests in Emerging Markets, which may be more volatile than more mature markets and the operational risks of investing are higher than in developed markets. The value of your investment could go down as well as up. In extreme circumstances this could result in a total loss of your investment


