The authorised fund manager of the Fund is Legal & General (Unit Trust Managers) Limited (the "Manager").

#### **OBJECTIVES AND INVESTMENT POLICY**

- The objective of the Fund is to provide growth in excess of the FTSE World Europe ex UK TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index over rolling three year periods after the deduction of all fees and expenses.
- The Fund is actively managed and seeks to achieve this objective by investing at least 90% in shares of companies that the Investment Manager considers to offer sustainable investment opportunities through their contribution towards the United Nations Sustainable Development Goals ("UN SDGs"), have strong growth prospects and are incorporated, listed, headquartered or which have their principal business activities in Europe excluding the UK.
- The Investment Manager will do so by taking into consideration the positive and negative impact that a company has from its products, solutions and/or services and business practices
- The Investment Manager's process to assess whether companies have a positive or improving environmental, social and governance profile is set out
- The Investment Manager will take into consideration a company's current and future trajectory of carbon emission intensity in the overall ESG profile of a company. This is achieved by measuring the carbon emission intensity for each company in the Fund using a third party data source and considering the overall carbon emission intensity of the Fund relative to the Benchmark
- The Fund will not actively invest in companies on the Investment Manager's Future World Protection List, Climate Impact Pledge or which derive any revenue from nuclear weapons, firearms, gambling or more than 5% of their revenues from the production of tobacco or alcohol.

  The Fund's portfolio is concentrated. Over a market cycle (typically 3-5
- years), the Fund will comprise on average 20-50 companies and is therefore "focused" when compared to a broad investment universe.
- The Fund may also invest in other shares (including of UK companies),

collective investment schemes (including those managed or operated by the Manager or an affiliate of the Manager), other transferable securities (including participatory notes, preference shares, permitted deposits, warrants and convertible bonds), cash and near cash, and money market instruments (such as treasury bills).

- The Fund may use derivatives (contracts which have a value linked to the price of another asset) to:
  - · reduce risk or cost; or
- generate additional capital or income with no, or an acceptably low, level

#### Other information:

- The Fund is actively managed as the Manager uses their expertise to select investments to achieve the Fund's objectives.
- Your units will be accumulation units. Income from the Fund's investments (dividends) will be reinvested back into the value of your units. You can buy or sell units in this Fund on any business day. You need to contact us with your instruction before 12 noon. This is the time we calculate unit prices for this Fund. If you contact us after 12 noon, the units will be bought or sold at the next business day's price. The Fund's base currency is denominated in GBP.
- This Fund is designed for investors looking for growth from a sustainable investment approach and an investment in European company shares (excluding UK companies).
  Although investors can take their money out at any time, this Fund may not
- be appropriate for those who plan to withdraw their money within five years.
- This Fund is not designed for investors who cannot afford more than a minimal loss of their investment.

- The return from this Fund is dependent on relatively few individual investments. This means that a fall in the value of an individual investment can have a major impact on the overall performance of the Fund. The Fund has a sustainability and/or ESG focus in its investment process which may i) limit the Fund's exposure to or exclude certain companies,


**Dilution adjustment:** On any day, the prices for buying or selling units in this Fund are the same. The Fund manager calculates a single price for this Fund based on the mid-point between the buying and selling prices of the Fund's assets. In certain circumstances, the Fund manager can adjust this price to account for whether there is more money going into or coming out of the Fund. This is called a 'dilution adjustment'

This can vary but as an example for this Fund we estimate 0.17% for purchases and 0.07% for sales at 31 December 2023. The amount of the

dilution adjustment may differ in future.
