The Authorised Fund Manager of the Fund is Evelyn Partners Fund Solutions Limited, trading as St Vincent St Fund Administration, part of the Evelyn Partners group.

Objectives and investment policy

The Fund aims to achieve income and capital growth over the long term (5-7 years).

The Fund will invest at least 80% of its assets in companies that are incorporated in or listed on exchanges in the Far East and Pacific Basin region, including Japan, Australia and India, or have significant business operations in this region.

The Fund invests in companies of any market capitalisation and in any industry or economic sector.

The Fund may make other investments, including:

- · other transferable securities
- · collective investment schemes
- shares (new issues)
- cash or near cash instruments, deposits and money market instruments
- warrants

In the light of extreme market conditions, the Manager may raise or reduce the liquidity of the Fund from normal working levels.

The Fund may use derivatives for Efficient Portfolio Management (EPM), i.e. to protect against market or currency movements, to reduce costs, or to earn income or capital.

Any income the Fund generates will be paid out to you.

You can buy and sell units on any working day in London.

The Fund is actively managed, which means that the manager has discretion over the composition of its portfolio, and the Fund is not tracking a benchmark nor is the Fund constrained by the value, price or components of a benchmark or any other aspect. The Fund is also not aiming to match or exceed the return of any benchmark.


