#### **Objectives and Investment Policy**

#### **Investment Objective:**

The Fund aims to provide capital growth and income by investing in a portfolio of emerging market bonds.

#### **Investment Policy:**

The Fund invests primarily in a mix of high and lower quality debt issued by governments or government-related entities of emerging markets. The Fund also invests in high and lower quality debt issued by companies based in emerging markets. The debt will be mainly denominated in US Dollars.

The Fund may invest more than 10% and up to 30% of its assets in securities issued by a single sovereign issuer with a lower credit rating. The Fund may invest up to 10% of its assets in Chinese onshore bonds through the China Interbank Bond Market, up to 10% its assets in convertible bonds. The Fund may invest up to 10% in contingent convertible securities, however this is not expected to exceed 5%. The Fund may invest up to 10% of its assets in total return swaps. However, this is not expected to exceed 5%.

The Fund may invest up to 10% of its assets in other funds and may invest in bank deposits, money market instruments for treasury purposes.


The Fund may also invest in derivatives and use them for efficient portfolio management purposes, hedging and cashflow management purposes. Derivatives will not be used extensively for investment

purposes. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- The reference currency of the Fund is USD. The reference currency of this share class is GBP.
- The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, JP Morgan EMBI Global Diversified.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- The deviation of the Fund's performance relative to the benchmark is also monitored, but not constrained, to a defined range.
- Income is distributed
- You may sell your investment on most working days.

## Material risks not fully captured by the Risk and Reward

- Callable Bond Risk Any unexpected behaviour in interest rates could negatively impact the performance of callable debt securities (securities whose issuers have the right to pay off the security's principal before the maturity date).
- CoCo Bond Risk Contingent convertible securities (CoCo bonds) are comparatively untested, their income payments may be cancelled or suspended, and they are more vulnerable to losses than equities and can be highly volatile.



#### Segregated liability

HSBC Global Investment Funds is an investment company ("Société d'Investissementà Capital Variable") with segregated liability between subfunds under Luxembourg law. This means that the holdings of one sub-fund are kept separate from the holdings of the other sub-funds and your investment in the Fund cannot be used to pay the liabilities of any other subfund.

The Fund is authorised in the Grand Duchy of Luxembourg and supervised by the Commission de Surveillance du Secteur Financier (CSSF). This key investor information is accurate as at 08 February 2024.
