abrdn Multi-Manager Diversity Fund, a Sterling denominated sub fund of the abrdn OEIC VII, B Acc Shares (ISIN: GB00B2941H05). This fund is managed by abran Fund Managers Limited.

OBJECTIVES AND INVESTMENT POLICY

Investment Objective

To generate capital growth and some income over the long term (5 years or more) by investing in a globally diversified portfolio of funds. Performance Target: To achieve a return in excess of the rate of inflation (currently as measured by the Consumer Price Index) over five years (before charges). The Performance Target is the level of performance the management team hopes to achieve for the fund. There is however no certainty or promise that they will achieve the Performance Target.lt has been chosen as the target as the Consumer Price Index is a commonly accepted measure of UK inflation.

Investment Policy Portfolio Securities

- The fund will invest at least 60% in actively managed funds, to obtain broad exposure to a range of diversified investments from a range of manaaers
- At least 30% of the fund will be invested in bonds (loans to a company or government) and cash or money market instruments.
- The rest of the fund will be invested in a selection of other funds investing in assets classes such as equities (company shares), commercial property and funds which can invest in a combination of traditional assets (such as equities and bonds) and non-traditional assets (such as Derivatives).

Management Process

- The management team use their discretion (active management) to
- maintain a diverse asset mix at country, sector and stock level.

 Their main focus is to select funds within each asset class and ensure that the asset allocation meets the fund's objectives.
- The fund will be subject to constraints which are intended to manage risk such as the fund must not hold more than 60% of its assets in equities. The constraints may very over time, and the fund's performance profile may deviate significantly from the Consumer Price Index over the long term.

Derivatives and Techniques

- The fund is not expected to invest in derivatives directly however it may invest in other funds which use derivatives more extensively.

Investors in the fund may buy and sell shares on any dealing day (as defined in the Prospectus).

If you invest in income shares, income from investments in the fund will bé paid out to you. If you invest in accumulation shares, income will be

added to the value of your shares.

Recommendation: the fund may not be appropriate for investors who plan to withdraw their money within five years. Investors should satisfy themselves that their attitude to risk aligns with the risk profile of this fund before investing.

RISK AND REWARD PROFILE



This indicator reflects the volatility of the fund's share price over the last five years which in turn reflects the volatility of the underlying assets in which the fund invests. Historical data may not be a reliable indication for the future.

The current rating is not guaranteed and may change if the volatility of the assets in which the fund invests changes. The lowest rating does not mean risk free.

The fund is rated as 4 because of the extent to which the following risk factors apply:

- The fund invests in securities which are subject to the risk that the issuer may default on interest or capital payments. The fund price can go up or down daily for a variety of reasons
- including changes in interest rates, inflation expectations or the perceived credit quality of individual countries or securities. The fund invests in equity and equity related securities. These are sensitive to variations in the stock markets which can be volatile and change substantially in short periods of time.


