# Invesco Sustainable UK Companies Fund (UK) (the "Fund") A fund of Invesco UK Investment Series (the "Company") Accumulation (No Trail) share class (ISIN: GB0033031047) (the "Share Class")

The Fund is managed by Invesco Fund Managers Limited, part of the Invesco Group.

### Objectives and Investment Policy

The objective of the Fund is to achieve long-term (5 years plus) capital growth.

- The Fund invests in companies that demonstrate sustainable characteristics that meet the Fund's environmental, social and governance (ESG) criteria described below, are financially sustainable and offer the opportunity for sustainable capital growth.
- The Fund invests at least 80% of its assets in shares of companies incorporated, domiciled or carrying out the main part of their economic activity
- in the UK.
- The Fund follows the following ESG methodology <sup>1</sup>: Negative ESG screening: The Fund will exclude companies with a defined level of involvement in a number of sectors, including but not limited to controversial weapons, coal, fossil fuels, tobacco, adult entertainment and gambling, as well as companies not compliant with the UN global
- compact principles. The current exclusion criteria may be updated from time to time.

  Positive ESG sustainability screening: The Fund will also weight overall exposure to those companies, based on the fund manager's proprietary
- Positive ESG sustainability screening: The Fund will also weight overall exposure to those companies, based on the fund manager's proprietary rating system, with acceptable practices and standards that sufficiently promote the environment, health and wellbeing and a fairer society (a society with less inequalities) in relation to their business operations, including, but not limited to those companies that have committed to reduce their greenhouse gas (GHG) emissions to net zero by 2050 in line with the Paris Agreement on climate change.

  The Fund may use derivatives (complex instruments) to manage the Fund more efficiently, with the aim of reducing risk, reducing costs and/or generating additional capital or income. Such derivatives may not be aligned with the Fund's ESG screening criteria.

  The Fund has an active investment approach based on stock selection driven by the fund manager's assessment of companies with sustainable ESG and financial characteristics underpinned by valuations that offer the opportunity for attractive and sustainable long-term capital growth. The Fund is not constrained by a benchmark and has a flexible approach with no inbuilt sector bias, with a preference for large sized UK companies as determined by their market capitalisation (total market value of a company's outstanding shares).

  The reference to (UK) in the Fund's name only relates to the Fund's domicile and is unrelated to the Fund's objective and investment policy. You can buy, sell and switch shares in the Fund on any Dealing Day (as defined in the Prospectus).
- You can buy, sell and switch shares in the Fund on any Dealing Day (as defined in the Prospectus). Any income from your investment will be reinvested.

- Recommendation: The Fund may not be appropriate if you plan to withdraw your money within 5 years.

Such derivatives may not be fully aligned with the Fund's ESG screening criteria.
- The Fund is invested in companies primarily domiciled in one country, any unfavourable conditions presented on them through country-specific conditions such as changes in regulation, business or economic policy may have a more negative impact on the Fund's performance than on the performance of a fund that is geographically diversified.


### Charges
