The authorised fund manager of the Fund is Legal & General (Unit Trust Managers) Limited (the "Manager").

### OBJECTIVES AND INVESTMENT POLICY

- Important notice:** Outcome of the EGM held on 3 March 2022 - Proposal to merge the L&G UK Special Situations Trust into the L&G Future World Sustainable UK Equity Fund: Following the EGM held this morning, we are pleased to announce that the Resolution was passed in favour of the merger. The merger will be implemented on 25 March 2022.
  - The objective of the Fund is to provide growth above that of the FTSE All Share TR Net Index, the "Benchmark Index". The Fund aims to outperform the Benchmark Index by 5% per annum. This objective is before the deduction of any charges and measured over rolling three year periods.
  - The Fund is actively managed and invest at least 80% in shares of UK companies. These companies are incorporated, headquartered or which have their principal business activities in the UK, or companies that are listed in the UK and constituents of the Benchmark Index.
  - The Fund invests in companies in special situations which are considered to be undervalued by the wider market, and which the Manager perceives to have a catalyst (which could include a feature or market event) which when realised should result in an improved valuation of the company.
  - Over a market cycle (typically 3 to 5 years), the Fund will comprise on average 30 to 60 companies selected by the Manager following research of each company. At times, the Fund's portfolio may be concentrated.
  - The Fund may also invest in participatory notes, preference shares, cash, deposits, money market instruments (such as treasury bills) and collective investment schemes, including those which are managed or operated by the Manager or an associate of the Manager.
  - In addition, the Fund is also permitted to receive and hold warrants and convertible bonds as a result of corporate actions.
  - The Fund may use derivatives (contracts which have a value linked to the price of another asset) to:
    - reduce risk or cost; or
    - generate additional capital or income with no, or an acceptably low, level of risk.

- The Fund is actively managed as the Manager uses their expertise to select investments to achieve the Fund's objectives.
  - Your units will be accumulation units. Income from the Fund's investments (dividends) will be reinvested back into the value of your units.
  - You can buy or sell units in this Fund on any business day. You need to contact us with your instruction before 12 noon. This is the time we calculate unit prices for this Fund. If you contact us after 12 noon, the units will be bought or sold at the next business day's price.
  - The Fund's base currency is denominated in sterling (British pounds).
  - This Fund is designed for investors looking for growth from an investment in shares of UK companies which are considered undervalued due to their special situation.
  - Although investors can take their money out at any time, this Fund may not be appropriate for those who plan to withdraw their money within five years.
  - This Fund is not designed for investors who cannot afford more than a minimal loss of their investment.

- The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. 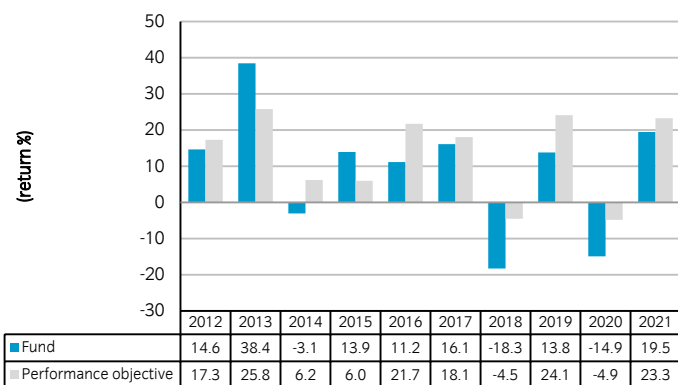

- There are no entry or exit charges.
- The ongoing charges figure is based on the latest available expenses at January 2022. This figure may vary from year to year.

### Other costs:

- **Dilution Adjustment:** on any day, the prices for buying or selling units in this Fund are the same. The Fund manager calculates a single price for this Fund based on the mid-point between the buying and selling prices of the Fund's assets. In certain circumstances, the Fund manager can adjust this price to account for whether there is more money going into or coming out of the Fund. This is called a 'dilution adjustment'. This can vary but as an example for this Fund we estimate 0.60% for purchases and 0.10% for sales at 01 March 2022. The amount of the dilution adjustment may differ in future.
