Objectives and investment policy

The investment objective is to reflect the upward and downward evolution of the FTSE 350 ex Inv Trust Qual/Vol/Yield Factor 5% Capped Index (net dividends reinvested) (the "Benchmark Index"), denominated in GBP and representative of bonds issued by euro zone governments with a maturity date greater than 25 years, while minimizing the volatility of the difference between the return of the Fund and the return of the Benchmark Index (tracking error).

The Benchmark Index is a subset of the FTSE MTS Eurozone Government Bond Investment Grade All Maturity Index.

The anticipated level of tracking error in normal market conditions is indicated in the prospectus.

The Fund seeks to achieve its objective via a direct replication, by investing primarily in the securities comprising the Benchmark Index.

To optimize the Benchmark Index replication, the Fund may use a sampling replication strategy, and may also engaged in secured securities lending. In addition, the indicative net asset value is published on the Reuters and Bloomberg pages of the Fund, and might also be mentioned on the websites of the stock exchanges where the Fund is listed.

The share currency is the Sterling Pound (GBP).

- Invested financial instruments: Derivatives and International equities.
- Dividend policy: the Fund's amounts available for distribution (if any) will be distributed.
- Net Asset Value: is daily calculated providing that the relevant stock exchanges are open for trading and orders can be covered.
- Redemptions: investors are able to redeem their shares on the primary market every valuation day before 17:00 Europe/Luxembourg and sell their shares on the secondary
 market at any time during trading hours on the Fund listing places.

The risk-return category shown above is based on the historical performance of the assets included in the Fund or the performance of its benchmark index or the computed performance of a portfolio model. Resulting from its exposure to the Benchmark Index, the Fund has been classified within category 5. Category 5 indicates that under normal market conditions a significant loss of capital is possible; the value of your investment may change significantly and have above average daily upside or downside variation.

Main risks not covered by the above indicator which could lead to a decrease in the net asset value of the Fund and which the Fund is authorized to disclose in this document (for more details about risks, please refer to the Risk Profile section of the prospectus):

- Counterparty risk: The Fund is exposed to the risk that any counterparty with which it has concluded an agreement or a transaction could become insolvent or otherwise default and more particularly when it has concluded financial derivative instruments over-the-counter or securities lending transactions. If such an event occurs, the net asset value of the Fund may decrease significantly. According to the regulation applicable to the Fund, such risk cannot exceed 10% of the Fund's total assets per counterparty.
- Operational risk: In the event of an operational failure of the management company or one of its representatives, investors could experience loss, delay in processing subscriptions, conversions, redemptions orders or other type of disruptions.

The charges you pay are used to pay the costs of running the Fund including the costs of marketing and distributing it. These charges reduce the potential growth of your investment. 
