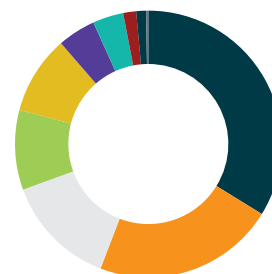

ASSET CLASS/GEOGRAPHICAL ALLOCATION

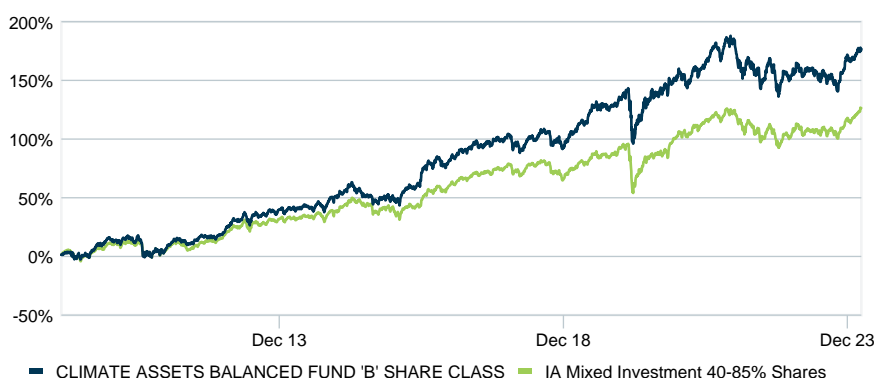
