

#### **Market Review**

In November 2023, the MSCI India IMI index was up 3.4%. It underperformed global indices like MSCI EM, US equities (S&P 500) and MSCI World, which were up 4.0%, 5.0% and 5.3%, respectively.

In Nov 2023, Foreign Institutional investors (FIIs) were net buyers to the tune of US\$2.3bn, while net buying by domestic institutional investors (DIIs) was US\$1.7bn. For the month, the Rupee depreciated by 4.4% vs the GBP while the 10-year G-Sec yields eased from 7.35% to 7.28%. Commodities declined, with Brent and S&P GSCI Industrial Metals Index down 6.2% and 3.4%, respectively.

For the month, Real Estate, Utilities and Health Care outperformed, while Consumer Staples, Financials and Information Technology underperformed. Large caps have underperformed mid and small caps, while State-owned entities outperformed their private peers.

#### **Performance Review**

The Fund was up 2.74% in November 2023, underperforming the benchmark by 63bps. The key contributors include Neuland Laboratories (+35.2%), Phoenix Mills (+25.0%), and Gokaldas Exports (+12.4%), whereas Cholamandalam Fin. Hold. (-17.4%), Shaily Engineering (-15.5%), and Aether Industries (-15.2%) were the key detractors.
