Objective and investment policy

The fund aims to provide a combination of capital growth and income, net of the ongoing charge figure, that is higher than the S&P 500 Index over any five-year period.

Core investment: At least 80% of the fund is invested directly in the shares of companies, across any sector and of any size, that are based, or do most of their business, in the US and Canada.

Other investments: The fund may invest in other funds (including funds managed by M&G) and cash or assets that can be turned into cash quickly. **Derivatives Usage:** To reduce risk and costs.

Strategy in brief: The fund employs a disciplined approach to analyse and select each company. The 'value' strategy invests in cheap and out-of-favour companies whose share price does not reflect accurately the valuation of the business. The fund manager seeks to identify companies which are, in their opinion at the time of investment, undervalued.

Benchmark: S&P 500 Index

The benchmark is a target which the fund seeks to outperform. The index has been chosen as the fund's benchmark as it best reflects the scope of the fund's investment policy. The benchmark is used solely to measure the fund's performance and does not constrain the fund's portfolio construction.

The fund is actively managed. The fund manager has complete freedom in choosing which investments to buy, hold and sell in the fund. The fund's holdings may deviate significantly from the benchmark's constituents.

For unhedged and hedged share classes, the benchmark is shown in the share class currency.

Other information

You can buy and sell shares in the fund on any business day. Instructions received before 12 noon will be dealt at that day's price.

Any income from the fund may be paid out to you annually.

In addition to the charges set out in the charges section, the fund will incur portfolio transaction costs which are paid from the assets of the fund. These can be higher when investing outside Europe.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

The entry and exit charges shown are the maximum figures and, in some cases, you may pay less. The exit charge will reduce by 0.5% after the investment has been held for one year, and will subsequently reduce by 1% per year until the investment has been held for five years. No exit charge will apply after five years. The above ongoing charge figure is an estimate of the charges because of a change to the charging structure with effect from 15 February 2021.

The charges are mostly, if not exclusively, the Annual Charge which may be discounted depending on the size of the fund. The Annual Charge without any discount is 0.95%. The fund's annual report for each financial year will include details on the exact charges made.

For Income shares, the ongoing charge is taken from investments held in the fund's portfolio and not from the income these investments produce. The deduction of this charge will reduce the potential growth of your investment.
