# Objectives and investment policy

### Objectives

The fund aims to provide capital growth and income of the ICE BofA Sterling 3 Month Government Bill Index + 4% per annum (before fees have been deducted\*) over rolling three year periods by investing in a diversified range of assets and markets worldwide. The fund also aims to target a volatility (a measure of how much the fund's returns may vary) range of 4% - 8% over the same period. #### **Investment Policy**

The fund is actively managed and invests directly, or indirectly through collective investment schemes, exchange traded funds, real estate investment trusts and closed ended funds, in equities, bonds, commodities and currencies worldwide. The weightings of these holdings are adjusted in response to changing market conditions.

The fund may invest more than 10% of its assets in collective investment schemes (including other Schroder Funds).

#### **Risk factors**

ABS and MBS risk: The fund may invest in mortgage or asset-backed securities. The underlying borrowers of these securities may not be able to pay back the full amount that they owe, which may result in losses to the fund. 
