## **Objectives and Investment Policy**

## **Investment Objective:**

The Fund aims to provide long term capital growth and income by investing in a diversified portfolio of bonds (denominated in Euros), while promoting environmental, social and governance (ESG) characteristics. The Fund's aims to have a higher ESG rating, calculated as a weighted average of the ESG ratings given to the issuers of the Fund's investments, than the weighted average of the constituents of its reference benchmark.

The Fund promotes ESG characteristics within the meaning of Article 8 of SFDR. More information on HSBC Global Asset Management's responsible investing policies is available at www.assetmanagement.hsbc.com/about-us/responsible-investing/policies.

#### **Investment Policy:**

In normal market conditions, the Fund will mostly invest in investment grade bonds and other similar securities issued by companies, or issued by government, government agencies or supranational bodies, that are denominated in Euro. The Fund includes the identification and analysis of an issuer's ESG Credentials as an integral part of the investment decision making process to reduce risk and enhance returns. The Fund will not invest in bonds issued by companies with involvement in specific excluded activities, such as: companies involved in the production of controversial weapons and tobacco; companies with more than 10% revenue generated from thermal coal extraction; and companies with more than 10% revenue generated from coal-fired power generation. The Fund conducts enhanced due diligence on bond issuers that are considered to be non-compliant with the UN Global Compact Principles. Please refer to the Prospectus for more details on ESG Credentials and Excluded Activities.

The Fund may invest up to 10% of its assets in other funds, may also invest in bank deposits, money market instruments for treasury purposes and up to 10% of its assets in contingent convertible securities. However, this is not expected to exceed 5%. The Fund may also invest in derivatives and may use them for the purposes of managing interest and credit risks and to enhance return when the derivative instruments will assist the Fund in achieving its investment objective. Derivatives may also be used for efficient portfolio management purposes.

- The Fund may enter into securities lending transactions for up to 29% of its assets.
   However, this is not expected to exceed 25%.
- The reference currency of the Fund is EUR. The reference currency of this share class is FUR
- The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, Markit iBoxx EUR Corporates.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- The deviation of the Fund's performance and underlying investments' weightings relative to the benchmark are monitored, but not constrained, to a defined range.
- Income is distributed.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 3 years.

## Material risks not fully captured by the Risk and Reward Indicator:

- Callable Bond Risk Any unexpected behaviour in interest rates could negatively
  impact the performance of callable debt securities (securities whose issuers have the
  right to pay off the security's principal before the maturity date).
- CoCo Bond Risk Contingent convertible securities (CoCo bonds) are comparatively untested, their income payments may be cancelled or suspended, and they are more vulnerable to losses than equities and can be highly volatile.

- Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.
- Credit Risk A bond or money market security could lose value if the issuer's financial health deteriorates.
- Default Risk The issuers of certain bonds could become unwilling or unable to make payments on their bonds.


