Investment Policy

The Fund invests in shares of listed companies which are based anywhere in the world (including countries which the fund manager considers to be emerging markets) and which the fund manager believes will provide aboveaverage returns. The Fund invests principally (meaning at least 80% of its assets) in large and medium-sized companies. The fund manager selects shares based upon analysis of a company's financial status, quality of its management, expected profitability and prospects for growth, taking into account the company's exposure to long-term themes influencing the global economy.


