Objectives and investment policy

The fund is passively managed. INVESTMENT OBJECTIVE: The aim is for your investment to track the performance, before fees and expenses, of the MSCI USA Banks 20/35 Capped index (index). DESCRIPTION OF INDEX: The index is based on the MSCI USA index (Parent index), which is designed to reflect the performance of large and medium sized companies representing 85% of the readily available shares in the United Stated of America. The index contains all of the constituents of the Parent index that are classified as Banks. The index is based on a methodology which limits the size of the largest Bank within the index at 35%, and all other Banks at 20%, with a buffer of 10% applied on these limits at each index rebalancing. INDEX REBALANCING, CALCULATION AND ADMINISTRATION: The index is calculated on a total return net basis. This means that all dividends and distributions by the companies are reinvested in the shares after tax. The index is reviewed and rebalanced on a quarterly basis and may also be rebalanced on an "as needed" basis. This means that the index is rebalanced at the end of any day on which the 35% and 20% limits (without the buffer) are breached. The index is calculated in US Dollars on a daily basis. 

To the extent the fund undertakes securities lending to generate revenue, the fund will ultimately be allocated 82% of the associated revenue, the securities lending agent, which will be a Deutsche Bank entity, will be allocated 9% and the remaining 9% will be allocated to the DWS entity which monitors such activities, as set out in the sales prospectus and/or supplement, for its own coordination and oversight

tasks. As securities lending revenue sharing does not increase the costs of running the fund, this has been excluded from the composition of costs.
