Objectives and investment policy

The objective is to provide a medium through which investors may participate in an actively managed portfolio of ordinary shares (equities) of companies in emerging markets, which contribute to or benefit from sustainable economic development.

The Fund seeks to achieve this by investing in ordinary shares (equities) and equity related securities such as warrants (the right to purchase a security, usually an equity, at a specific price within a certain time frame) of companies that are registered in emerging market countries which contribute to or benefit from their sustainable economic development.

The manager will only invest in companies that demonstrate a clear commitment to Good Governance and Sustainability. Companies will be required to meet standards, including board balance and independence, transparency and disclosure and the protection of shareholder rights. They must also demonstrate a clear commitment to sustainable environmental and social practices.

The Fund may invest in financial and currency futures contracts (the purchase of an asset at a predefined price and a predetermined future date) for the purposes of hedging and efficient portfolio management.

The Fund is actively managed. The Manager believes that an appropriate comparator benchmark for reviewing fund performance is the MSCI Emerging Markets NR Index, given the investment policy of the Fund and the approach taken by the manager. The Fund is not constrained by this benchmark and has significant freedom to invest in a portfolio that is materially different to the benchmark's own composition.

Income generated by the Fund may be paid to you annually.

There is no minimum holding period for this Fund. However, it may not be appropriate for investors who plan to withdraw their money in under 5 years.

You may withdraw your investment on demand during any working day in Luxembourg. Your withdrawal instruction must be received before 12.00 central European time in order for your investment to be withdrawn the same day. Proceeds will normally be paid to you three business days later.

Risk and reward profile

The Risk and Reward Indicator table demonstrates where the Fund ranks in terms of its potential risk and reward. The higher the rank the greater the potential reward but the greater the risk of losing money. It is based on past data, may change over time and may not be a reliable indication of the future risk profile of the Fund. The shaded area in the table below shows the Fund's ranking on the Risk and Reward Indicator.

Historical data may not be a reliable indicator of the Fund's future risk profile thus the risk category shown is not guaranteed and may change over time. The lowest category does not mean 'risk free'.

The given rank reflects the effect of the Fund investing mainly in equities. Equities generally provide higher rewards and higher risk.

The indicator does not take into account the following risks:

Counterparty Risk: to gain greater income the Fund may deposit cash with various approved Counterparties. Return of the cash is dependent upon the continued solvency of the Counterparty.

Currency Risk: your investment may be adversely affected by changes in currency exchange rates.

Liquidity Risk: the ability to buy and sell assets at a favourable price may be affected by a low level of counterparties willing to enter into a transaction with the Fund.

Market Risk: the value of assets held by the Fund may go down as well as up. There can be no assurances that the investment objectives of the Fund will be achieved.

Warrants: small movements in the price of the asset to which the warrant relates may result in a disproportionately large movement, up or down, in the price of the warrant.

Emerging Market Risk: investing in Emerging Markets may provide greater rewards but carries greater risk due to possibility of low liquidity, high currency fluctuation, the adverse effect of social, political and economic security, weak supervisory structures and weak accounting standards.

Sustainability Screening Risk: the screening out of sectors or companies on governance and sustainability grounds may mean the Fund is more sensitive to price swings than an equivalent unscreened fund.

Charges

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.


