The authorised fund manager of the Fund is Legal & General (Unit Trust Managers) Limited (the "Manager").

OBJECTIVES AND INVESTMENT POLICY

- The objective of the Fund is to provide a combination of income and growth.
 The Manager will aim to identify a combination of investments that are expected to produce income together with the potential for growth.
- The Fund is actively managed will have exposure to shares in companies, Other information: bonds (both company and government), money market instruments (such treasury bills), cash, deposits and indirectly to property and alternative asset classes (such as commodities). The shares in companies may represent all economic sectors and geographical areas. The Fund will have exposure of between 20% and 60% to shares in companies and at least 30% to bonds and money market instruments.
- To obtain the exposure to shares in companies, bonds, cash and money market instruments, the Manager may invest directly or indirectly in collective investments schemes (both active and index tracking) including those which are managed and operated by the Manager or an associate of the Manager. At times the Fund could hold
- up to 100% in other funds; or
- up to 100% directly in the assets.
- The bonds that the Fund invests in may be investment grade (rated as lower risk); or
- sub-investment grade (rated as higher risk)
- Investment and sub-investment grade bonds are bonds that have been given a credit rating by a rating agency. Credit ratings give an indication of how likely it is that the issuer of a bond will be able to pay back interest and the loan on time.


CHARGES
