## **Objective and investment policy**

**Objective:** The fund aims to provide a combination of capital growth and income that is higher than the Numis Smaller Companies Index (excluding Investment Companies), net of the Ongoing Charge Figure, over any five-year period.

Core investment: At least 80% of the fund is invested in the shares of smaller companies, across any sector, that are listed in the UK. These companies are at the initial time of purchase:

• in the bottom 10% (by market capitalisation) of the FTSE All-Share Index; or

- in the Numis Smaller Companies Index (excluding Investment Companies); or
- listed on the Alternative Investment Market.

**Other investments**: The fund may invest in other funds and cash or assets that can be turned into cash quickly.

Derivatives usage: To reduce risk and costs.

**Strategy in brief**: The fund manager selects stocks using a bottom-up approach. A long-term perspective is adopted with particular focus placed on the factors driving a company's growth, its competitive advantage, change, quality of management and valuation.

**Benchmark**: Numis Smaller Companies Index (excluding Investment Companies) The benchmark is a target which the fund seeks to outperform. The index has been chosen as the fund's benchmark as it best reflects the scope of the fund's investment policy. The benchmark is used to measure the fund's performance and, together with the other index, and the Alternative Investment Market as referenced in "Core investment" constrains the fund's portfolio construction as they define the investment universe of the fund.

The fund is actively managed. Within the given constraints, the fund manager has complete freedom in choosing which investments to buy, hold and sell in the fund. The fund's holdings may deviate significantly from the benchmark's constituents.

For unhedged and hedged share classes, the benchmark is shown in the share class currency.

#### Other information

You can buy and sell shares in the fund on any business day. Instructions received before 12 noon will be dealt at that day's price.

Any income from the fund may be paid out to you semi-annually.
