Objective and investment policy

The fund aims to provide:

· an annual yield of 4-6%; and

· capital growth, net of the Ongoing Charge Figure, over any five-year period. Core investment: At least 80% of the fund is invested directly and indirectly in emerging market assets including:

• at least 25% of the fund directly in company shares across any sector and of any size that are based, or do most of their business, in emerging markets;

• at least 25% of the fund directly in bonds issued by companies or other similar issuers, or by governments and other public issuers that are based, or do most of their business, in emerging markets; and

property-related securities.

Other investment: The fund may also invest in other securities, including developed market equities and bonds, other funds (including funds managed by M&G) and cash or assets that can be turned into cash quickly.

Derivatives usage: For investment purposes and to reduce risk and cost.

Strategy in brief: The fund employs a bottom-up approach to find the best investments to deliver on its income target while striving to generate long-term capital growth. The fund's allocation between bonds and shares is an output of the investment process and portfolio construction and, as such, will be the result of the fund manager investing in the best ideas, individually and relatively, across the capital spectrum.

The fund is actively managed and it has no benchmark. Investors can assess the performance of the fund by its objective. The fund's annual report for each financial year will include details of the fund's performance in relation to its objective.

Other information

You can buy and sell shares in the fund on any business day. Instructions received before 12 noon will be dealt at that day's price.

Any income from the fund may be paid out to you monthly.

In addition to the charges set out in the charges section, the fund will incur portfolio transaction costs which are paid from the assets of the fund. These can be higher when investing outside Europe.
