Objectives and Investment Policy

Investment Objective:

The Fund aims to provide long term capital growth by investing in a portfolio of Chinese shares, while promoting environmental, social and governance (ESG) characteristics. The Fund promotes ESG characteristics within the meaning of Article 8 of SFDR. Investment Policy:

In normal market conditions, the Fund will invest at least 90% of its assets in shares (or securities similar to shares) of companies of any size that are based in or carry out the larger part of their business activities in, China, including Hong Kong SAR. The Fund includes the identification and analysis of a company's ESG Credentials as an integral part of the investment decision making process to reduce risk and enhance returns. ESG Credentials may include environmental and social factors, and corporate governance practices. The Fund will not invest in companies with involvement in specific excluded activities, such as: companies involved in the production of controversial weapons and tobacco; companies with more than 10% revenue generated from thermal coal extraction; and companies with more than 10% revenue generated from coal-fired power generation. The Fund conducts enhanced due diligence on companies that are considered to be non-compliant with the UN Global Compact Principles. 
and excluded activities. The Fund may invest up to 70% in China A and China B-shares. For China A-shares, up to 70% through the Shanghai-Hong Kong Stock Connect and the Shenzhen-Hong Kong Stock Connect, up to 50% in China A-shares Access Products (CAAPs) and up to 10% in CAAPs issued by any single issuer.

The Fund may invest up to 10% of its assets in other funds, up to 10% in Real Estate Investment Trusts (REITs) and may invest in bank deposits, money market instruments for treasury purposes.

The Fund may also invest in derivatives and use them for efficient portfolio management purposes, hedging and cash flow management purposes. Derivatives will not be used extensively for investment purposes. Derivatives may also be embedded in other instruments used by the Fund.

- The Fund may enter into securities lending transactions for up to 29% of its assets.
 However, this is not expected to exceed 25%.
- The reference currency of the Fund is USD. The reference currency of this share class is GBP.
- The Fund is actively managed and does not track a benchmark. The Fund has an internal or external target to a reference benchmark, MSCI China 10/40 Net.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- Any deviations with respect to the benchmark are monitored within a comprehensive risk framework, which includes monitoring at security level.
- The deviation of the Fund's performance relative to the benchmark is also monitored, but not constrained, to a defined range.
- The reference benchmark has a high level of concentration. This means that a small number of securities make up a significant proportion of the benchmark.
- Income is distributed.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

Why is this Fund in this specific category?

This Fund is classified in category 6 because its price or simulated data has shown high fluctuations historically.

Material risks not fully captured by the Risk and Reward Indicator:

- Counterparty Risk The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.
- Emerging Markets Risk Emerging markets are less established, and often more volatile, than developed markets and involve higher risks, particularly market, liquidity and currency risks.
 Exchange Rate Risk Changes in currency exchange rates could reduce or increase
- Exchange Rate Risk Changes in currency exchange rates could reduce or increase investment gains or investment losses, in some cases significantly.


