## **Objectives and Investment Policy**

## **Investment Objective:**

The Fund aims to provide long term capital growth and income by investing in a portfolio of shares from Brazil, Russia, India and China (including Hong Kong SAR).

## **Investment Policy:**

In normal market conditions, the Fund will invest at least 90% of its assets in shares (or securities similar to shares) of companies of any size, that are based in, or carry out most of their business in Brazil, Russia, India and/or China (including Hong Kong SAR). Investments in Chinese share markets include China A-shares and China B-shares with a maximum exposure of 50% of the Fund's assets. The Fund may invest up to 40% of its assets in China A-shares through the Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect. The Fund may invest up to 30% of its assets in China A-shares indirectly through China A-shares Access Products (CAAP) and may invest up to 10% of its assets in other funds, including HSBC funds and may invest in bank deposits, money market instruments for treasury purposes.

The Fund may also invest in derivatives. The Fund may use them for hedging and cashflow management purposes. Derivatives will not be

- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.

- You may sell your investment on most working days.


