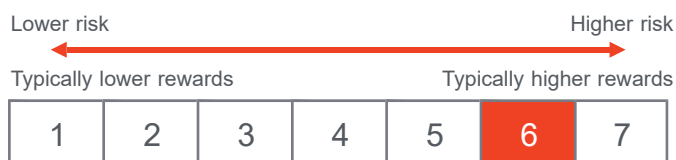

Objectives and Investment Policy

- The aim is to provide capital growth and income on your investment over time.
- The Fund will invest normally at least 90% of its assets in equity securities (i.e. shares) in companies of any size that are based in or which carry out most of their business in BRIC countries. BRIC countries are Brazil, Russia, India and China (including Hong Kong SAR).
- Investments in Chinese equities include China A-shares and China B-shares with a maximum exposure of 50% of the Fund's assets. The Fund may invest up to 40% of its assets in China A-shares through the Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect and have up to 30% of its assets exposed to China A-shares indirectly through China A-shares Access Products (CAAP).
- The Fund may invest up to 10% of its assets in funds (including other funds of HSBC Global Investments Funds).
- The Fund may use derivatives to meet its investment objectives.
- The Fund may use derivatives for hedging and cash flow management.
- The Fund may enter into securities lending transactions for up to 29% of its assets. However, this is not expected to exceed 25%.
- The reference currency of the Fund is USD. The reference currency of this share class is GBP.
- The Fund is actively managed and does not track a benchmark. The reference benchmark for the Fund is 25% MSCI Brazil Net| 25% MSCI China Net|25% MSCI Russia Net|25% MSCI India Net.
- The Investment Advisor will use its discretion to invest in securities not included in the reference benchmark based on active investment management strategies and specific investment opportunities. It is foreseen that a significant percentage of the Fund's investments will be components of the reference benchmark. However, their weightings may deviate materially from those of the reference benchmark.
- Income is distributed.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

Why is this Fund in this specific category?

This Fund is classified in category 6 because its price or simulated data has shown high fluctuations historically.

Material risks not fully captured by the Risk and Reward Indicator:

- **Concentration Risk** The Fund may be concentrated in a limited number of securities, economic sectors and/or countries. As a result, it may be more volatile and have a greater risk of loss than more broadly diversified funds.

- **Counterparty Risk** The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.
- **Emerging Markets Risk** Emerging markets are less established, and often more volatile, than developed markets and involve higher risks, particularly market, liquidity and currency risks.
- **Exchange Rate Risk** Changes in currency exchange rates could reduce or increase investment gains or investment losses, in some cases significantly.
- **Investment Leverage Risk** Investment Leverage occurs when the economic exposure is greater than the amount invested, such as when derivatives are used. A Fund that employs leverage may experience greater gains and/or losses due to the amplification effect from a movement in the price of the reference source.

Charges

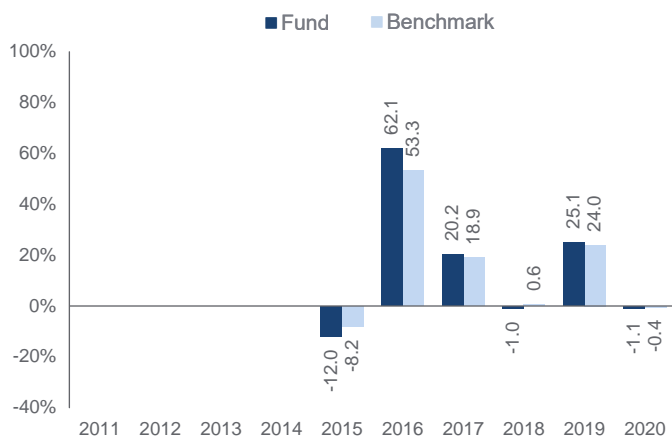
